### William Livingston II Replenishment Blood Drive

Friday, August 28, 2015 12 p.m. to 5 p.m. Founders Hall St. Monica Church Parish (formerly Christ the Divine Teacher Parish) 116 Thorndale Road Chippewa, PA 15010 District Judge William R. Livingston II is currently undergoing treatment for Acute Myeloid Leukemia (AML). Judge Livingston has a distinguished career in law enforcement and judicial affairs. He was appointed by Pennsylvania Governor Edward G. Rendell in November 2005 to fill the unexpired term of retiring District Judge Donald Eiler.

Judge Livingston is a 1969 graduate of Beaver Falls High School; he studied Criminal Justice at the Community College of Beaver County. He graduated from the PA State Police Academy receiving State Certification as a municipal police officer and went on to enjoy a law enforcement career that spanned more than 30 years.

He attended Minor Judiciary Education Training in Chambersburg, PA and received his magisterial District Judge Certification in 2004. His dedication to public service continued as he was affirmed by the electorate of the district with an impressive election victory and full six-year term beginning in 2008. In 2013, Judge Livingston was re-elected for another six- year term until 2020. He has also served as a volunteer firefighter for more than 20 years.

Judge Livingston was active as a football coach for New Brighton for 17 years. He has been a member of the Cruzin Few Unique Vehicle Club since 1996 and a four-year member of the Valley H.O.G. Chapter. Judge Livingston is married to the former Christine Wilson from New Brighton. They have four sons and ten grandchildren.

This blood drive is scheduled by the Valley H.O.G. members to help the community blood supply from which he has used and will continue to use during his treatment.

Central Blood Bank is the not-for-profit organization that supplies the blood products and transfusion-related services to more than 40 hospitals in western Pennsylvania, northern West Virginia and eastern Ohio.
