

Sherman Hostetter

Sherman Hostetter, Jr. of Beaver, Pennsylvania, attended Penn State University on a Golf Scholarship from 1973-77 and graduated with a major in real estate and insurance. Presently, he continues the family auction business, started by his parents in 1955, as a full time auctioneer and real estate broker licensed in PA, OH and WVA. Added to his credentials are the notable titles of past President of the Auction Marketing Institute, past President of the Pennsylvania Auctioneers Association, and past President of the Northwest Chapter of the PAA. Sherman is also twice a past board member of the National Auctioneers Association and a past board member of the National Association of Realtors Auction Committee. In 1992 he won the Pennsylvania Auctioneers Association Bid Calling Championship and 2010 won the West Virginia Auctioneers Association Bid Calling Championship. In 2013 Sherman was inducted in the Pennsylvania Auctioneers Association Hall of Fame.

In addition, Sherman holds many designations such as; the Certified Auctioneers Institute (CAI), Accredited Auctioneer of Real Estate (AARE), Graduate Personal Property Appraiser (GPPA), Graduate Realtor Institute (GRI), Certified Residential Specialist (CRS), Senior Real Estate Specialist (SRES), Certified Estate Specialist (CES), and is a Certified Paralegal through Penn State University. Since 2003 Sherman has served on the Pennsylvania State Board of Auctioneer Examiners, appointed by then Governor Edward G. Rendell, and is currently the Chairman of the Board. His passion for the auction business is only surpassed by his love of golf, which he played professionally from 1978 to 1982. Sherman Hostetter Group LLC (Hostetter Auctioneers) conducts over 150 auctions annually specializing in the areas of real estate, estates and business liquidations. Sherman works a bi-weekly auto auction for Goodwill Industries of Pittsburgh.

Hostetter Auctioneers conducts over 40 fundraising auctions nationwide each year raising in excess of a million dollars annually. He has presented numerous auction and real estate educational seminars at state and national auctioneers conventions as well as a past instructor for the Accredited Auctioneer Real Estate designation. Sherman also hosted a radio talk show “Inside the Auction World” on 1230 WBVP and 1460 WMBA in the Western Pennsylvania area. His community involvement includes volunteering for his church, community teen Bible study and past school board director for the Blackhawk School District in Beaver Falls, PA. Sherman enjoys working in the family auction business with his son Matt, daughters Kylee and Paige, and son-in-law Dan Reeder all auctioneers. Sherman Hostetter Group LLC (Hostetter Auctioneers) currently has a total of 12 auctioneers, 2 full time secretaries and 5 setup crew members on staff providing complete online and onsite auction services in real estate and personal property to Pennsylvania, Ohio and West Virginia.

Joined Valley Hog in 2003 after retirement. My first motorcycle ride was at age 14 or 15 when some "older" guys challenged this skinny kid. I promptly dumped the '47 Indian with a suicide clutch on top of me. Of course I got right back on it and rode around the block. Didn't know it then but I was hooked.

Graduated from Stowe High School in 1960 which is in beautiful downtown McKees Rocks (by the way, that is also **Jake's** hometown and he is one year older than I).

Joined the US Air Force and served from 1960 to 1964 as an Air Traffic Controller. Spent most of my enlistment, three years, in England where I befriended some cafe racers that let me ride their bikes. I have to tell you that riding a bike fast on the wrong side of the road is a scary proposition.

Graduated from Kent State University in December of 1967 with a BBA and a major in accounting. Had a roommate that owned a Harley and got to enjoy riding without ever having to own one once again.

Spent nine years with the accounting firm of PriceWaterhouse where I was able to earn my CPA license. Did a three year stint with a small, local steel fabricator before moving on to a firm that designed and built exhibits for the trade show industry where I remained for 25 years until my retirement in 2003. My tenure with the exhibit firm started as VP of Finance and proceeded to Division President and then to Eastern Regional Vice President.

After raising two children, who have begat four grand kids, and nearing the supposed "golden years" I decided it was time to buy my own bike and she is still with me today. I purchased a 2002 Heritage Softail Classic - - Jake figured me to be a typical RUB that would only ride a couple of hundred miles a year. My wife told me if I got a bike, she would leave me - she is still with me and I am considering suing for breach of contract. This bike and I have been to 44 of the lower 48 states and next year I am planning to get in most of Canada and the remaining four states which are in the upper left hand corner of the US. My first long ride was from Orange County, California to Washington DC.

In addition to HOG, I am a member of PA Chapter 4 of Rolling Thunder. I also serve as Treasurer of the Motorcycle Riders Foundation that is a lobbying group for motorcycle rights. All bikers should consider joining and help to keep this great lifestyle safe from the beaureaucrats in the nation's capital.

Since joining Valley HOG, I have acquired a new hero - - **Mel Bundy**. See, he is about seven years older than I am and I use him as a gauge on how much longer I can enjoy the open road. As my grandfather would say "**corsa libero**."
